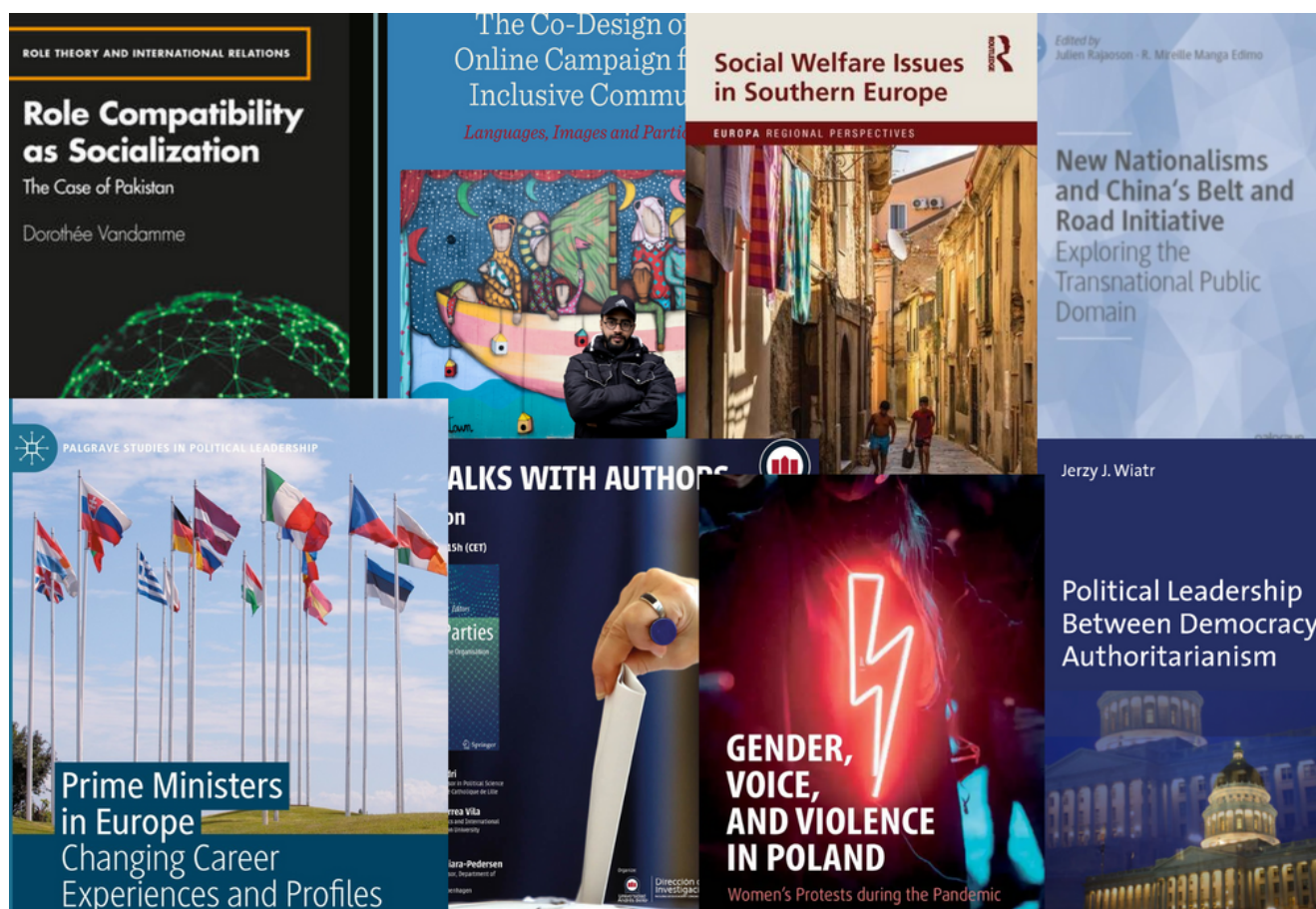

***Gender, Voice, and Violence in Poland: Women's Protests During the Pandemic.* Edited by Adrianna Zabrzewska & Joshua K. Dubrow, IFiS PAN Publishers, 2022.**



New book, *Gender, Voice, and Violence in Poland: Women's Protests during the Pandemic*, edited by Adrianna Zabrzewska & Joshua K. Dubrow and published by IFiS PAN Publishers. This book was funded by the National Science Centre, Poland (2016/23/B/HS6/03916).

In autumn 2020, as the second wave of the Covid-19 pandemic began, Poland's Constitutional Tribunal issued a ruling that severely restricted access to abortion. Massive street protests, led by Strajk Kobiet (Women's Strike), quickly followed. This sourcebook presents, in English, the voices of activists, politicians, and academics on the 2020 protests in Poland after the Constitutional Tribunal's ruling.

Sources include press conferences, interviews, public speeches, and parliamentary committees and debates, translated into English and commented on by Polish feminist scholars. The book is designed to generate insights into the

relationship between inequality, street protest, institutions, and violence, for use in research, teaching, journalism, and activism.

***New Nationalisms and China's Belt and Road Initiative.* Edited by Julien Rajason & R. Mireille Manga Edimo, Palgrave Macmillan, 2022.**

This book is a treatise on cultural globalization and the global political economy.

By introducing the transnational public domain in the study of China's Belt and Road Initiative (BRI), the book goes beyond existing theoretical frameworks involving both the 'clash between civilizations' and the 'time-worn division' of the world into North and South.

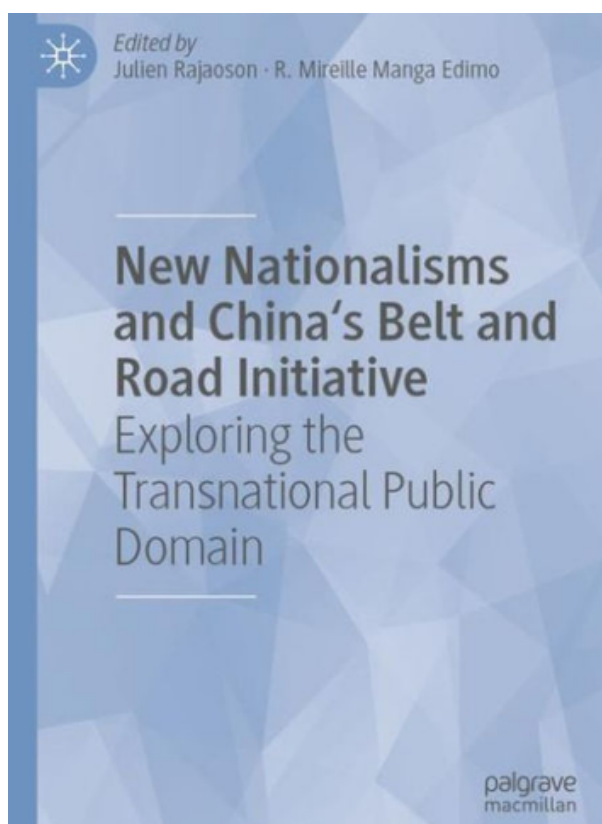
It advances a new focus on the theoretical and empirical elements that canvass global cultural behaviours and reactionary attitudes to the expanding Chinese economic norms, cultures and values in different national contexts.

Readers of political theory, global political economy, globalization, international relations, political sociology, cultural sociology, public policy and foreign policy analysis will find interest in the book.

Whereas new nationalism couples with globalism, both concepts are rediscovered through various socio-economic contexts of BRI

policy discourses, which produce conflicts, solidarities, new economic partnerships, and cooperation and resistance as types of contemporary nationalism.

The new nationalism is approached as a dual-sided, relational, and dialectical phenomenon which readers will capture by paying particular attention to both the global and local scales of the social responses to the BRI.

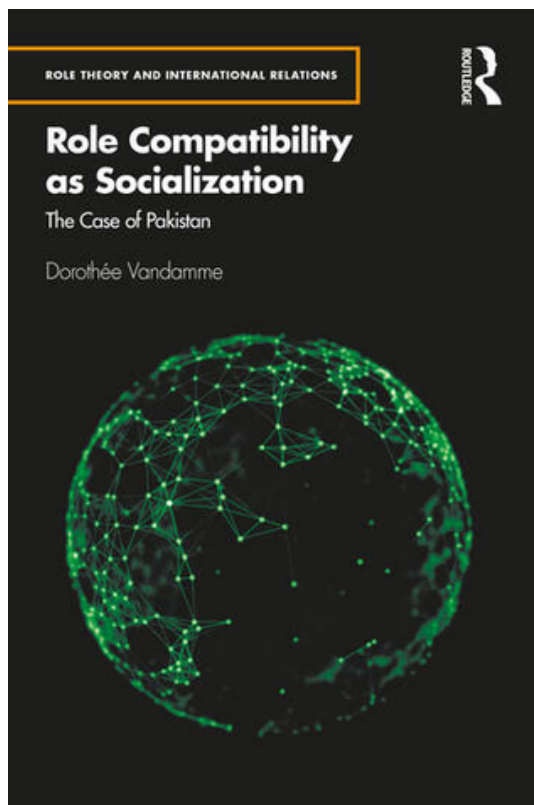

***Role Compatibility as Socialization. The Case of Pakistan.* Dorothée Vandamme, Routledge, 2022.**



In *Role Compatibility as Socialization*, Dorothée Vandamme examines Pakistan's socialization process in terms of role compatibility in the 2008-2018 period.

Adopting an Interpretative phenomenological analysis (IPA) method of analysis, Vandamme builds on role theory to develop a theory of socialization as role compatibility to explain the dynamics of Pakistan's (dys)functioning position and its status-seeking process as a fully functioning member of the international system. Specifically, she focuses on how Pakistani civilian and military leaders define their country's positioning towards India, the United States and China. In doing so, she traces the link between domestic role contestation at the country's inception and the resulting domination of the military's conception of their country, state identity, how it projects itself externally and how it is received by others.

Departing from strictly structural or agent-oriented explanations, Vandamme expertly demonstrates Pakistan's perceived role compatibility with significant

others and underlines the causality between state identity, foreign policy behavior and socialization. *Role Compatibility as Socialization* will be of interest to graduate students and researchers who work on and with role theory and socialization theory, and for those with a research interest on South Asia.

She is a researcher at the ISPOLE institute and a research fellow at the European Foundation for South Asian Studies. Her main research interests are political sociology and social processes in interstate relations, the political and security environment in Pakistan and Afghanistan, Chinese foreign policy and contemporary international security issues.

***Prime Ministers in Europe. Changing Career Experiences and Profiles.* Ferdinand Müller-Rommel, Michelangelo Vercesi & Jan Berz, Palgrave Macmillan, 2022.**

This book examines the changes in the career experiences and profiles of 350 European prime ministers in 26 European democracies from 1945 to 2020. It builds on a theoretical framework, which claims that the decline of party government along with the increase of populism, technocracy, and the presidentialization of politics have influenced the careers of prime ministers over the past 70 years. The findings show that prime ministers' career experiences became less political and more technical. Moreover, their career profiles shifted from a traditional type of 'party-agent' to a new type of 'party-principal'. These changes affected the recruitment of executive elites and their political representation in European democracies, albeit with different intensity and speed.

***Political Leadership Between Democracy and Authoritarianism.* Jerzy J. Wiatr, Verlag Barbara Budrich, 2022.**



This book sheds light on the theory of political leadership, which is still an under-researched field of political science. It is related to the philosophical argument about determinism versus activism and helps to understand the basic conflict of the 21st century between liberal democracy and new authoritarianism. The book looks at Max Weber's typology of political rule and his concept of the ethics of responsibility, which are key to the theory of leadership. The author shows that the unfinished contest between democracy and new authoritarianism in the 21st century confirms the importance of leadership in old and new democracies as well as in the neo-authoritarian regimes and calls for a new type of political leaders.

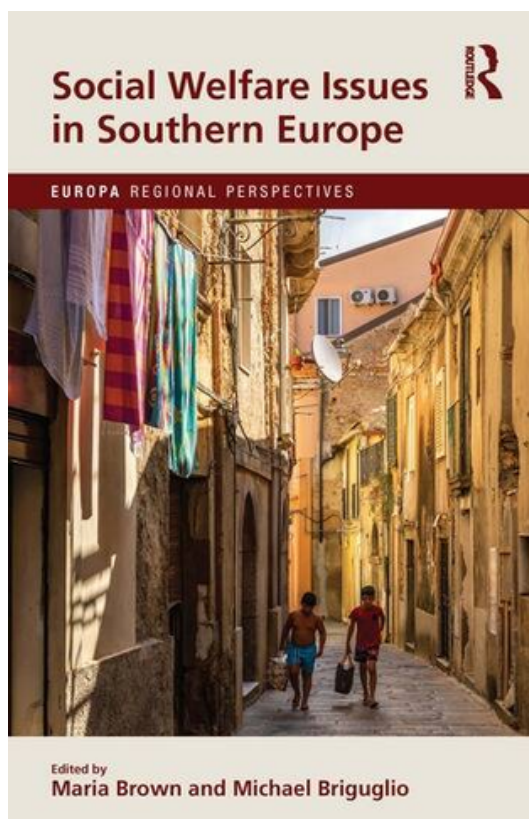

***Social Welfare Issues in Southern Europe.* Edited by Maria Brown & Michael Briguglio, Routledge, 2022.**

This volume is the first of its kind to discuss social welfare issues using case studies from a broad range of Southern European countries, both large and small, a decade after the financial crisis. It identifies similarities and differences in the ways in which Southern European countries engage with specific welfare issues and examines whether Southern European welfare is distinct from that of the rest of the continent. The book also engages with the impact of COVID-19 on the social welfare issues under investigation. The volume is divided into four sections, each examining in detail issues including employment, education, health, sexuality, globalization, social movements and migration.

With its contributions from experts in the field, the volume is recommended for academics, researchers and students of sociology, social policy, economics, education, politics and social movements.

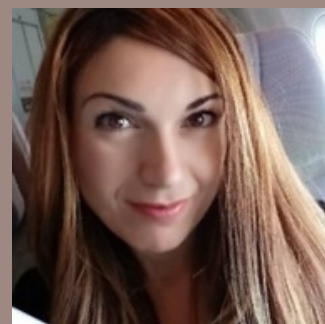

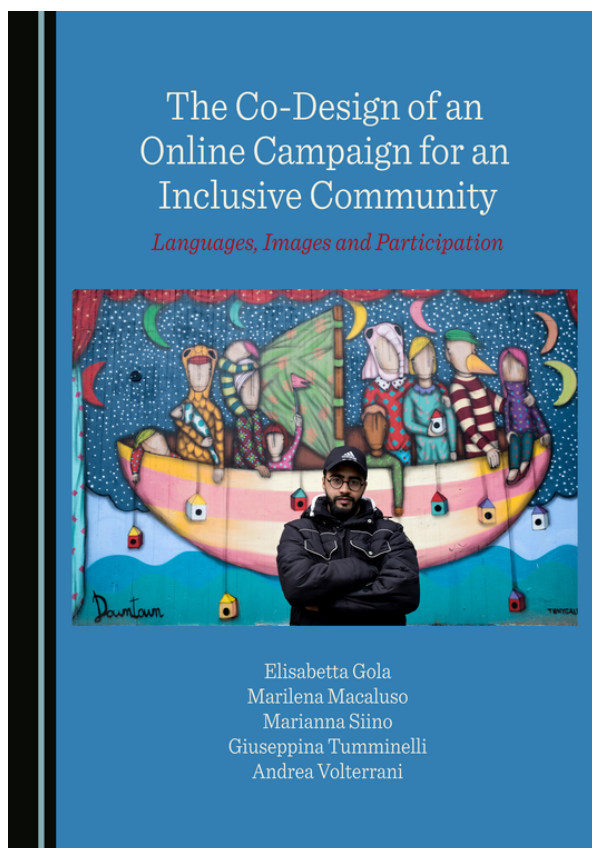

El libro *Menores, Migrantes en Tiempos de Pandemia*, compila, en el marco del Proyecto con referencia DER2017-89623-R, la reflexión y aproximación que más de 30 autores de distintos campos de las Ciencias Sociales y Jurídicas, realizan sobre las condiciones legales, derechos humanos y escenario socioeducativo de los flujos migratorios de menores, jóvenes y otras poblaciones vulnerables, en especial, desde el auge de la Pandemia de la Covid-19. Un período marcado por un aumento de los radicalismos y cuestionamientos de valores democráticos, ante el auge y viralización de contenidos desinformativos, y el uso que se ha hecho del colectivo migrante como recurso de presión política entre países. Una realidad que, más allá de las diferencias que pueden darse en las diferentes zonas del planeta, entraña retos y realidades comunes, que exigen conocerse, compartirse y asimilarse. Por ello, este libro espera ser un aporte a la comunidad académica

y profesional, interesada en la temática general migratoria abordada a lo largo de los 26 capítulos de los investigadores expertos que integran esta obra, articulada en torno al eje de la pandemia. Sobre todo, si deseamos conocer aspectos afines y diferenciadores que se han venido experimentando en zonas tan diversas como la ruta de Centroamérica y Mediterránea, que comparten la realidad vivida por jóvenes que salen de sus países por una búsqueda de una mejora de sus condiciones de vida, a manos de grupos delictivos o no, y cuya travesía les hace experimentar una realidad provista de pérdida de derechos humanos, peligros y la llegada a una sociedad receptora, muchas veces hostil. Una obra fundamental para conocer de forma interdisciplinar las circunstancias actuales del fenómeno migratorio global a la luz de la pandemia.

Since the beginning of the 21st century, we have observed the rise of authoritarian regimes in several countries but also the development of authoritarian modalities within formal democracies. In what contexts and by what means is this authoritarianism being implemented? From the questioning of individual freedoms, restrictions on pluralism, the non-respect of the rule of law, arbitrary power, to the repressive or even totalitarian forms adopted by certain States, the concrete conditions of these authoritarianisms vary according to the context and invite us to reopen the question of the definition of the phenomenon and the identification of its criteria. What issues distinguish these contemporary authoritarianisms from older ones? How do authoritarian regimes differ according to their context of emergence? In Latin America, for example, authoritarian regimes are established against a backdrop of increased socio-economic inequalities and are spreading, leading to a regression in social, sexual and reproductive rights, even going so far as to call into question the question of the separation of church and state, as in Jair Bolsonaro's Brazil. In Europe, the authoritarian drifts of certain governments, such as that of Mateusz Morawiecki in Poland or Viktor Orbán in Hungary, bear witness to forms of state centralization and arbitrary control of the media and the population, pushing back the boundaries of the rule of law. The recent management of the pandemic was in some cases a context conducive to the concentration of power in the hands of the

state, whether through the use of digital techniques or emergency measures. In addition, contemporary authoritarian forms are finding increasingly important relays in certain non-state actors such as religious institutions, neighborhood associations, social movements, citizens' groups, or mobilized collectives, which participate in the implementation of repression and control.

Yet authoritarianism also meets resistance in many states, such as the anti-corruption and anti-authoritarianism movements in Brazil, the feminist movements in Argentina, Chile, and South Korea, or the political mobilizations of students and young people challenging the legislation on the protection of state secrets. What can political sociology say about these reconfigurations? How can we analyze these authoritarian forms and their resistance? What obstacles and limits do anti-authoritarian mobilizations in these contexts face? This call, therefore, invites colleagues from different backgrounds to rethink the definitions of authoritarianism, their boundaries, and their contexts, in order to account for the conditions of implementation of these regimes, the social and political environment of these forms of government, the resistance they produce, and the circulation of these notions at the international level.

With this call, we invite proposals for international panels presenting approaches to political sociology in the broadest sense, whether theoretical or based on empirical investigations. A comparative dimension between several regions of the world is welcome. The main axes to which the proposals may respond are the following:

- 1) Authoritarian drifts and relations with economic regimes (effects and dynamics of globalization, demobilizing effects of neoliberalism, etc.).
- 2) Forms of surveillance and control of populations (justice, police authorities, media, technological tools, etc.).
- 3) Citizen participation in authoritarian regimes and in the defense of public morality (voting, abstention, defense of religious ideas, etc.).
- 4) Resistances to authoritarianisms and democratic experiences (participation and protest powers, feminist social movements, climate movements, etc.).
